#### **1 Who is the Investing Entity?**

- An Investing Entity could be an “**individual**” OR a “**Company/ Partnership/ Proprietorship firm**” looking to file an investment intent to UP NRI department to invest in Uttar Pradesh.

#### **2 Who is an Individual Investor?**

- An individual investor could be a professional - employed with a company/ firm - or an owner/ majority stakeholder of a business located outside India and wants to invest in the state of Uttar Pradesh in his personal capacity. The individual - HNI (High Net Worth Individuals) - is expected to have a substantial investible surplus to do so.

#### **3 What is a Company/ Firm Investment?**

- An investment can also be done by a Company/ Partnership/ Proprietorship Firm. In such cases the investor shall give details of the investing company/ firm.
- Investor Type – Business Owners of Indian Origin / Company and Partnership firm located outside India/ Authorized Employee or Team member who is driving the investments of the Investing entity.
