### WHAT TO EXPECT

Israel is much like India, particularly in terms of its culture and hospitality and the embrace of the principle 'Atithi Devo Bhava.' The locals exhibit a warm and helpful attitude, mirroring the sentiment of treating guests with genuine care and respect.



Israel climate is hot and humid in summers, and mild in winters.



India is 3.5 to 4.5 hours ahead of Israel Standard Time (IST). However, when Israel adopts Daylight Saving Time, the time difference reduces to 2.5 to 3.5 hours, as Israel moves its clocks forward by one hour.



Hebrew is the official language of Israel, and English is the most commonly used foreign language. Being familiar with select Hebrew words will help you if you are working in Israel. Here's a guide to common phrases and translations useful for working and living in Israel:

Boker tov: Good morning

B'seder: Okay

- Qualifications: Skilled in the field applied for
- Language Skills: Proficient in Intermediate Level English
- Education: Completed 10 Years of Schooling with High School Diploma
- Prior Experience: No Previous Employment in Israel
- Clean Record: Clear Police Report from India; No History of Substance Abuse
- Family Relations: No Immediate Family Residing or Employed in Israel
- Health Standards: Physically and Mentally Fit; No Chronic Diseases
- Citizenship: Indian Citizenship Required

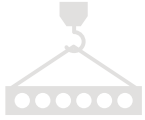

- Employment contract: Minimum 12 months, extendable to 63 months
- Salary: The minimum monthly salary is set at 6,100 NIS (equivalent to 137,000 INR) Additionally, the employer will take care of your Accommodation, Food, Health and Medical insurance

## Step 2.

Candidates meeting the criteria will need to submit original documents and appear for an interview



## Step 3.

Candidates shortlisted by the employer will have to take a trade test and medical check in designated hospitals. The costs are to be paid by the candidates.



## Step 4.

NSDC will assist candidates with travel arrangements, including visa application and airline ticket purchase at market rates (to be paid by the candidate). The arrival date in Israel should be no later than 30 working days from the date of employment offer.



## Step 5.

NSDC will share the list of shortlisted candidates with the employer.

## Step 6.

Candidates must undergo a background verification including criminal record check and the associated fees will be paid by the applicants.

### Please note:

1. Candidates are responsible for paying any Passport Issuance Fee, if required.
2. Final candidates need to pay ₹ 10,000/- to NSDC as part of the Registration and Processing fee,
3. Candidates will attend the pre-departure orientation under NSDC's supervision.
4. Upon arrival in Israel, candidates will be assigned to construction sites by the employer.
5. At the end of their employment period in Israel, candidates need to pay for their own return flight ticket.

## FREQUENTLY ASKED QUESTIONS

### Q: Why Work in Israel?

Israel's construction industry is growing rapidly and there is a need for many skilled construction candidates for roles such as framework, iron bending, ceramic tiles, plastering, and more. Indians wanting to explore a global career should consider Israel as an option as the country offers competitive wages, great working conditions, and the chance to learn new technologies and tools.

### Q: Is it safe to work in Israel?

The Israeli government and businesses are committed to ensuring the safety and well-being of all individuals, including foreign employees. Strict measures are in place to safeguard residents and employees during periods of heightened tension. The presence of over thousands of foreign candidates in the country proves the fact that many individuals continue to work and live in Israel without any major disruptions.

Additionally, Israel has a vibrant Indian community, providing a sense of family and support for Indians working in the country.



## Q: How many Indians are working in Israel?

According to sources, there are approximately 18,000 Indians presently working in Israel.



## Q: What are the requirements for working in Israel?

Below are the basic requirements for the specified job roles in the construction sector.

- Age Range: 25–45 Years
- Qualifications: Skilled in the field applied for
- Language Skills: Proficient in Intermediate Level English
- Education: Completed 10 Years of Schooling with High School Diploma
- Prior Experience: No Previous Employment in Israel
- Clean Record: Clear Police Report from India; No History of Substance Abuse
- Family Relations: No Immediate Family Residing or Employed in Israel
- Health Standards: Physically and Mentally Fit; No Chronic Diseases
- Citizenship: Indian Citizenship Required

## Q: Who will be my employer?

Candidates will be employed with a registered employer in Israel.

It's also important to note that the National Skill Development Corporation (NSDC) only acts as a facilitator in the process, aiding candidates in completing the various steps required for employment. NSDC plays a supportive role in assisting candidates through the stages of the employment process, ensuring a smoother transition into their roles with the employer in Israel.



## Q: What about my VISA and work permit?

If selected, the initial visa and work permit granted to you will be valid for one year. The extension can be granted for a maximum period of 63 months by your employer.



## Q: Which opportunities are available for me in Israel?

There are various job roles available for Indian candidates, including 3,000 positions for Shuttering Carpenter, 3,000 for Iron Bending, 2,000 for Ceramic Tile, and 2,000 for Plastering.



## Q: What would be my salary?

The minimum monthly salary for all job roles is set at 6,100 NIS (equivalent to 137,000 INR), subject to potential deductions for taxes and accommodation expenses. Overtime pay and wages during holidays will be calculated in accordance with Israeli Labor Law, ensuring that candidates are fairly compensated for their hard work.



## Q: Are there any taxes?

The tax slabs in Israel are structured as follows:

- 0 – 6,790 NIS: 10%
- 6,791 – 9,730 NIS: 14%
- 9,731 – 15,620 NIS: 20%
- 15,621 – 21,710 NIS: 31%
- 21,711 – 45,180 NIS: 35%

Additionally, there is a fee for social security insurance based on the following slabs:

- 0 – 6,331 NIS: 0.04%
- Each NIS exceeded 6,331 NIS: 0.87%



## Q: What about health insurance?

A: The employer is obligated to provide private medical insurance to the candidate for the entire duration of their employment. To cover the cost of this insurance, there will be a monthly fee deduction from the candidate's wage. This deduction is set not to exceed approximately 134.46 NIS.

We also recommend you to buy the Pravasi Bhartiya Bima Yojana offered by the Government of India that provides a cover of upto INR 10,00,000.

## Q: What are the working hours?

A: You will be required to work 236 monthly working hours.



## Q: Where will I receive my salary?

A: candidates will have their own bank accounts in Israel, and the salary will be directly credited to these accounts.



## Q. Where will I stay in Israel?

A: Your employer will furnish you with accommodation and food during your stay in Israel. The cost of accommodation and food will be deducted from your monthly wage.

## Q: How can I send my salary to my family in India?

A: You can do an International bank transfer to send your salary to anyone in another country



## Q: What costs would I need to bear for the process of application?

A: It is important to note that as a candidate, you will be responsible for covering various expenses related to the application process and relocation to Israel.

## Q. Will I need to cover any additional fees once in Israel?

Other than the specified fees for the recruitment process and the cost of your return flight ticket at the end of your employment period, no additional fees are required to be paid by the candidate.



## Q: What if I fall sick in Israel or have an emergency?

You will receive assistance for medical requirements and emergencies in compliance with the laws and regulations governing labor in Israel.



## Q: Will my employer detain my passport?

Holding a candidate's passport against their will is a severe criminal offense. It is illegal for employers, Manpower Companies, placement agencies, or any other entities to retain your passport without your consent. If your passport is detained, the employee may file a complaint against his employer to the PIBA call center at 1-700-707-889. ## Q. What happens if I am not selected for the program?
